

**THE CORPORATION OF THE VILLAGE OF POUCE COUPE
TAX RATES
BYLAW NO. 943, 2011**

A bylaw for the levying of rates for Municipal, Hospital, and Regional District purposes for the year 2011.

The Council of the Corporation of the Village of Pouce Coupe, in open meeting assembled enacts as follows:

1. This Bylaw shall be cited as "The Corporation of the Village of Pouce Coupe **Tax Rates Bylaw No. 943, 2011**".
2. The following rates are hereby imposed and levied for the year 2011:
 - (a) For all lawful general and debt purposes of the municipality on the value of land and improvements taxable for general municipal purposes, rates appearing in Column "A" of the schedule attached hereto and forming a part hereof;
 - (b) For hospital purposes on the value of land and improvements taxable for Regional Hospital district purposes, rates appearing in Column "B" of the schedule attached hereto and forming a part hereof;
 - (c) For purposes of the Peace River Regional District on the value of land taxable for regional district purposes, rates appearing in Column "C" of the schedule attached hereto and forming a part hereof;
 - (d) For purposes of the Peace River Regional District on the value of improvements only for the Emergency 911 system taxable for regional district purposes, rates appearing in Column "D" of the schedule attached hereto and forming a part hereof;
3. The minimum amount of taxation upon a parcel of real property shall be **One Dollar (\$1.00)**
